



Annual Meeting Minutes

September 14, 2023

Opening

Call to order from President Gary Gary Chullino at 6:11 pm

Board members Michelle Wells, Joe Fennessy, Gary Chullino, Ken Royster and Alejandro Oyarzabal were present

Nineteen homes were represented.

Introductions

The Board members and committee chairs were introduced.

Special Guests

Mayor Pro Tem Beto Lopez (District 3) Discussed developments in the area.

LS is now the sixth largest city in Missouri, behind Independence.

The city is suing Jackson county over recent assessment hikes.

City is working on improving the area around the LS airport, within our district, to accommodate more high end arrivals.

PRI land – 1200 acres owned by the Mormon church – are going up for sale and we can expect development in that area. Additionally, two new lanes will be added to Todd George up to Wood Chapel.

Councilmember Phyliss Edson (District 3)

Final year representing us – is terming out.

Looking to develop Lakewood in 5 yrs to include a bike lane.

Fire Station 4 being built on Bowlin Road will include a rescue boat and will open in April 2024

City needs more road repairs including the 291 bridge over 50 and 470 should be wider.

On October 10 District 3 will hold a town hall at the LSPD training facility from 5-7p.

There have been no applications for adjacent Stag's Field apartments – so far the project is understood as attached homes which will nevertheless increase traffic in the area.

There are 5 schools districts within the city of Lee's Summit

Captain Mike Moran, LSPD

Discussed traffic on Georgian and Woods Chapel. Traffic complaints are the #1 issue. Georgian is considered an arterial street that receives 1300-1500 cars/day with a 4000 car limit. In 2019, the average speed was 27 mph with 85% of traffic driving within limits. Recently they had cars patrolling the area for 25 hrs and averaged 1 stop per hour.

Officer Geno, LSPD Community Interactive Group

In the area over the last 12 months there were 39 events, 11 reports of which 19 were officer initiated and 20 citizen calls. 5 stealing reports and 1 stolen auto.

Financial Report - Joe

This year we signed a 5 year contract with Trash company to reflect the terms of the current situation allowing for annual adjustments.

Updated the phone system at the pool which will not be turned on and off each season.

Board agreed to raise our assessment 10% to ensure our budget covered our increasing expenses. Our budget surplus this year is being used to offset the increase, ultimately decreasing the amount paid by each home year over year. The credit is applied to all assessment invoices.
